### 1. Enhancements

### 1.1 OME Meets: Making Entries During the Team Entry Period

For OME meets that are in the team entry stage, coaches can now add entries or change the attendance status of invited swimmers before the team entry deadline in:

- AUI > a meet > Actions > Entry by event
- AUI > a meet > Actions > Entry by name
- AUI > a meet > Actions > Attendance status

Entries added or attendance status changes in the AUI during the team entry period are synced and displayed in the Portal of the invited swimmer, and vice versa.

#### Note:

- Entries added or attendance status changes in the AUI prior to the team entry start date are not displayed in the Portal until after the team entry start date.
- Coaches can enter entries for an invited swimmer even if the swimmer did not respond to the invitation.
- If a coach has entered entries for a swimmer, but the swimmer subsequently responds with "not attending" or changes the attendance status from "attending" to "not attending", then the swimmer's relay and individual entries are removed.
- If a swimmer enters an entry in the Portal but the coach subsequently removes it in the AUI, then the swimmer can re-enter it again in the Portal.
- During the team entry period, entries added in the AUI can be removed by the swimmer in the Portal.
- After the team entry deadline, swimmers cannot make any further changes to the added entries or attendance status in the Portal.

### 1.2 Indirect Tax

To reflect the recently released OMS inclusive-tax feature, tax-inclusive orders now display **Adjust consumer** tax in the AUI > **REPORTS** > **Transactions** report > **Type** column:






## 1.3 New Feature Onboarding

To promote new features to agency users and help them understand how to use a feature, when agency staff or coaches log in to the Swim Manager AUI (or for newly signed-up agencies, when they complete account setup), an onboarding guide consisting of up to five slides to introduce new features is displayed. For example, the following features are highlighted in the latest onboarding guide:


- Batch Pausing/Resuming All Billing Schedules (feature released on May 12<sup>th</sup>)
- Saving Credit Card Information During CUI Checkout (feature released on April 26<sup>th</sup>)
- OME Meets: Making Entries During the Team Entry Period











Agency staff or coaches can:

- Click > or **Next** to proceed to the next slide.
- Click < to return to the previous slide.</li>
- Click **X** or **Done** to close the slideshow (note: after closing, the same onboarding guide will not be shown again for the same user account).


## 1.4 Strong Password requirement

During self-sign-up (**Create an organization > SwimManager**), agency administrators now must provide a strong password that includes at least:

- 8 characters
- three of the following:
  - lowercase letters
  - uppercase letters
  - numbers
  - special characters

Since agency administrators must be over 18 to create a new team, they must now enter their **Contact information** > **Date of Birth**:





If existing agency users log in with a weak password, then they must now change their password in Passport to a strong password before logging in.



# 2. Resolved Issues

- Previously, meet statuses were inconsistent between the home page and meet overview page. This issue has been resolved in this release.
- Previously, agencies were unable to import .SD3 results files with a missing AgeOrClass(64-66) field into AWS programs. This issue has been resolved in this release.
